MINIMUM QUALIFICATIONS:

- One (1) year professional experience in a customer service environment
- Valid driver license. Must obtain Florida driver license within thirty (30) days of employment.
 - Driving history for the past three (3) years must reflect no violations of a driving related offense, <u>or</u> driving under the influence (DUI) which includes both drugs and alcohol, reckless driving, or hit and run involving an occupied vehicle or attended property, <u>or</u> an accumulation of traffic violations, plus three (3) points for each attendance at driving school (regardless of whether points were assessed against the license) where the penalty points do not exceed twelve (12).

PREFERABLE QUALIFICATIONS:

- Experience in Parks, Recreation, or related field.
- Experience in setting up and breaking down special events
- Valid American Red Cross CPR/AED Certification. Must obtain within ninety (90) days of employment.

POSITION FUNCTION:

Assist the Park Ranger Staff when extra manpower is needed to operate and maintain City Parks.

NOTE:

Applicants will be required to complete an Affidavit of Good Moral Character; an Authorization for Criminal History Check; and a Level 2 national fingerprint-based records check. Must sign and agree to the Tattoo and Reporting to Work Conditions of Employment.

TASK/DUTY

Assist the Park Ranger Staff in the operation and maintenance of City Parks.

Assist the Park Ranger Staff in staging (setting-up) special events.

Assist the Park Ranger Staff in dealings with patrons in the parks, including answering questions, enforcing rules, and ensuring visitor safety.

Operate various duty stations within the park.

Perform other duties as needed when assigned by a supervisor.

May drive to and from various city work locations to set up or break down event sites.
