Violations Comments

Violation #33. Proper cooling methods; adequate equipment

Observed cooler to the right of main cooking area displaying condensation and water dripping onto containers of food. PIC stated there was a work order for the cooler. Advised to move food containers that were directly below where the water was dripping.

CODE REFERENCE: 64E-11.003(2). Proper methods shall be used for cooling in accordance with Rule requirements. There should be enough equipment to meet the demand of the food operation.

Violation #47. Food & non-food contact surfaces

Observed cutting boards with deep marks. Discard or resurface.

CODE REFERENCE: 64E-11.003(4). Equipment and utensils must be properly designed, constructed, and in good repair.

Violation #56. Ventilation & lighting

Observed two lights out 1 by the dishwashing area and 1 by cooking area. Replace bulbs.

CODE REFERENCE: 64E-11.003(6)(a). Adequate exhaust ventilation hood systems in food prep and warewashing areas shall be provided and designed. 50 foot candles shall be at surfaces where employees work with food and 20 foot candles shall be at surfaces where food is provided to consumers.
